Lice 'N' Simple

Pour-On Equine Lousicide



Active Constituents

Triflumuron 25 g/L

Actions

Contains the insect growth regulator triflumuron, which interferes with insect chitin synthesis and acts primarily against immature lice, causing death by rupturing the malformed cuticle and/or by insect starvation.

Indications

Effective control of biting lice *Werneckiella* (also known as *Damalinia* or *Bovicola*) *equi* on horses, with a single treatment.

Warnings

Combustible liquid. Keep away from flames and hot surfaces. Toxic to aquatic life with long lasting effects. Toxic to terrestrial invertebrates. Avoid release to the environment. Collect spillage.

Precautions

Use with caution on horses with existing dermatitis or broken skin. Apply during the cooler part of the day, preferably in the shade. Do not use if rainfall is pending.

Withholding Periods

Horses producing meat or offal for human consumption must not be sold for slaughter during treatment or within 91 days following the last treatment.

Directions for Use

Dose horse at 1 mL/10 kg bodyweight. Do not underdose. Apply to a dry coat. Using the measuring cup provided, apply in a single continuous strip down the middle of the backline from the poll to the highest point of the rump. In particular ensure good coverage to the roots of the mane. Do not hose the horse for at least 72 hours after treatment. Treatment during the hottest part of the day is not recommended. After use, clean measuring cup in warm soapy water. Ensure new or cleaned rugs are used on the animal after treatment to avoid reintroduction of lice.

First Aid

Causes skin irritation and serious eye irritation. If skin irritation or eye irritation persists, or if you feel unwell, contact a doctor or the National Poison Centre. Phone 0800 POISON (0800 764 766). IF ON SKIN: Wash with plenty of soap and water. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

Clear liquid: 100 mL

Storage

Store below 30°C (room temperature). Store in original container, tightly closed in a safe and well-ventilated place.

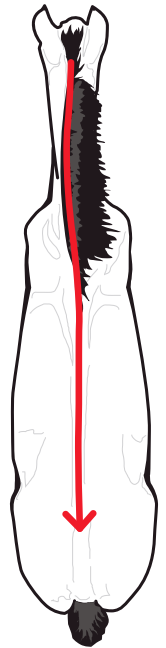
